

ZoomCharts Report License Agreement (EULA)

This ZoomCharts Report License Agreement (this “**Agreement**”) is a legal agreement between **Data Visualization Software Lab SIA** (d/b/a **ZoomCharts**) and the individual or entity that purchases or downloads a Report (defined below) (“**Licensee**”). “ZoomCharts” is a trademark of Data Visualization Software Lab SIA. By purchasing, downloading, installing, or using a Report, Licensee agrees to be bound by this Agreement.

1. Definitions

- “**Report**” means any data visualization report, template, dashboard, workbook, sample dataset, configuration file, PBIX/Power BI file, or related asset made available by ZoomCharts through **zoomcharts.com** (the “**Shop**”), including any updates or modifications provided by ZoomCharts.
- “**Organization**” means the Licensee’s legal entity, including its employees and individual contractors working on Licensee’s behalf and under confidentiality obligations.
- “**Download**” means the acquisition of a single Report from the Shop under a valid license.
- “**Subscription Year**” means the 12-month period starting on the Subscription License activation date and each subsequent 12-month renewal term.
- “**Download Token**” means a unit of entitlement that permits the Licensee to download **one (1)** Report under the 10 Downloads/Year subscription plan.
- “**Privacy Policy**” means ZoomCharts’ privacy policy available at <https://zoomcharts.com/downloads/privacy-policy.pdf>, as updated from time to time, which is incorporated herein by reference solely for matters related to personal data processing.
- “**Site**” means zoomcharts.com and any subpages where Reports are listed for purchase/download.
- “**Third-Party Software**” means any software or services not provided as part of the Report itself, including without limitation **Microsoft Power BI Desktop/Service** and any other platform required to run or view the Report.
- “**Custom Visual(s)**” means any data visualization component or add-in that is licensed separately from the Report, including **ZoomCharts custom visuals** and third-party visuals.
- “**Drill Down Visuals**” means **ZoomCharts Drill Down** custom visuals compatible with Microsoft Power BI.
- “**Bundled Visual License**” means a complimentary, time-limited **developer license** for Drill Down Visuals that ZoomCharts may provide with certain Reports, as described in Section 21A.

2. License Types

2.1 Single-Download License

Upon payment of the applicable fee, ZoomCharts grants Licensee a non-exclusive, worldwide, non-transferable, non-sublicensable, **perpetual** license to download **one (1)** Report and to use it solely as permitted in Section 3.

2.2 Subscription License — 10 Downloads/Year

Upon payment of the applicable subscription fee, ZoomCharts grants Licensee a non-exclusive, worldwide, non-transferable, non-sublicensable license to **download up to ten (10) Reports per Subscription Year** from the Shop and to use each downloaded Report as permitted in Section 3. Each Report downloaded under an active subscription is licensed to Licensee on a **perpetual** basis for internal use per Section 3. **Unused Download Tokens** at the end of a Subscription Year will **carry forward** to the next Subscription Year **only if** the subscription is **renewed without lapse**; if the subscription is not renewed, any unused Download Tokens **expire** at the end of the Subscription Year.

2.3 Subscription License — Unlimited Downloads/Year

Upon payment of the applicable subscription fee, ZoomCharts grants Licensee a non-exclusive, worldwide, non-transferable, non-sublicensable license to **download an unlimited number of Reports during each Subscription Year** and to use each downloaded Report as permitted in Section 3. ZoomCharts may apply **reasonable technical limits** and **fair-use** measures to prevent abuse (e.g., automated scraping or mass redistribution attempts). Each Report downloaded under an active subscription is licensed to Licensee on a **perpetual** basis for internal use per Section 3.

2.4 File Access & Re-Downloads

- **Single-Download purchases:** The purchased Report remains available in the Licensee's Shop account for **re-download for one (1) year** from the purchase date. The **license to use** the Report remains **perpetual**, subject to this Agreement.
- **Subscription downloads (10-per-year or Unlimited):** Reports downloaded while the subscription is active remain available for **re-download only while the subscription remains active**. If the subscription lapses, Licensee may continue to use any Reports already downloaded (perpetual internal-use license), but **re-download access** from the Shop account may be disabled until the subscription is reactivated.

2.5 Upgrades, Downgrades & Carryover

- **Upgrade to Unlimited:** If Licensee exhausts all available Download Tokens (including any carried-forward tokens) under the **10 Downloads/Year** plan, Licensee may upgrade to the **Unlimited Downloads/Year** plan at any time. The upgrade becomes effective upon ZoomCharts' confirmation in the Shop. **Proration and billing** terms (if any) are as stated on the Shop at the time of upgrade. After upgrading, Download Tokens are no longer applicable for the then-current Subscription Year.
 - **Carryover on Renewal (10-per-year):** Unused Download Tokens **carry forward** to the next Subscription Year **only with uninterrupted renewal**. Tokens are account-bound, non-transferable, and have **no cash value**. ZoomCharts may display the current token balance in the Licensee's Shop account.
 - **Downgrades:** Moving from Unlimited to the 10-per-year plan takes effect **at the next renewal**. No retroactive credits are issued unless expressly stated on the Shop.

3. Permitted Use

Subject to this Agreement, Licensee may:

1. **Internal/Organizational Use.** Install, run, and use the Report for Licensee's own internal business needs, including within Licensee's Organization, on any number of devices owned or controlled by Licensee.
 2. **Internal Modifications.** Modify, adapt, and create derivative works of the Report **solely for internal use within the Organization**. All such derivatives are subject to the restrictions in Section 4 and remain owned as set out in Section 7.
 3. **Embedded Use Internally.** Embed the Report in Licensee's internal analytics environments (e.g., internal Power BI workspaces/servers) accessible only to the Organization.

4. Restrictions

Licensee **must not**:

1. **Redistribute or Share Externally.** Distribute, publish, gift, sell, rent, lease, loan, sublicense, transfer, or otherwise make the Report or any derivative works **available to any third party** outside the Organization, including by posting on public or shared repositories, marketplaces, or websites.
2. **Repackage or Resell.** Use the Report (or derivatives) as part of a product or service offered to third parties, including managed services, SaaS, or consulting deliverables where the Report files are delivered to a client.

3. **Public Hosting.** Host or make the Report accessible over the internet to persons outside the Organization, including through public Power BI services or live share links that are accessible to non-Organization users.
 4. **Challenge Submissions.** Use the Report (or derivatives) as a submission to **ZoomCharts Challenges/Contests** or any similar competition.
 5. **Remove Notices.** Remove, obscure, or alter any proprietary notices, author credits (if displayed), or license terms embedded in the Report.
 6. **Sublicense.** Grant any third party any rights to the Report or derivatives.
 7. **Reverse Legal Terms.** Use the Report in violation of applicable laws, including data protection, export, and sanctions laws.

5. Attribution

ZoomCharts may display author attribution for some Reports. Licensee must **not** misrepresent authorship of Reports or derivatives. Licensee may remove visual attribution **only** for internal use where removal is technically necessary and does not imply authorship by Licensee. Nothing in this Section limits the privacy choices or data subject rights described in the Privacy Policy (e.g., where an individual requests that their name not be displayed publicly on the Site).

6. Access Control

Licensee is responsible for implementing reasonable access controls to ensure only members of the Organization can access the Report or derivatives. Sharing with external individuals (including customers, partners, or contractors not under the Organization's direct control and NDA) is prohibited without a separate written license from ZoomCharts.

7. Ownership

Except for the limited licenses expressly granted herein, **ZoomCharts and its licensors (including Report authors)** retain all right, title, and interest in and to the Reports, derivatives, and all intellectual property rights therein. No rights are granted by implication, estoppel, or otherwise.

8. Updates; Support

ZoomCharts may, but is not obligated to, provide updates, fixes, or new versions. Any updates provided are licensed under this Agreement. Unless expressly stated on the Shop, the license does not include support or implementation services.

9. Fees; Taxes

All fees are payable as listed on the Shop at the time of purchase and are non-refundable except as required by law. Prices exclude taxes, duties, and levies, which are the responsibility of Licensee.

10. Privacy; Personal Data

ZoomCharts processes personal data related to purchases, account management, licensing, fraud prevention, and compliance **as described in the Privacy Policy** (<https://zoomcharts.com/downloads/privacy-policy.pdf>), which is **incorporated by reference** for the sole purpose of describing such processing. In the event of a conflict between this Agreement and the Privacy Policy regarding **how** personal data is processed, the Privacy Policy controls. Licensee is responsible for ensuring it has a lawful basis to process any personal data that Licensee inputs into or uses with the Report. The Privacy Policy also includes ZoomCharts' **contact details** for privacy requests (including access, correction, objection, or deletion) and describes how to contact the supervisory authority.

11. Confidentiality

Reports and related non-public materials provided by ZoomCharts are confidential to the extent not publicly available through the Shop. Licensee will use at least reasonable care to protect such materials from unauthorized disclosure.

12. Term and Termination

This Agreement takes effect upon purchase/download and continues:

- For **Single-Download purchases**, perpetually unless terminated for breach (license to the specific purchased Report is perpetual; re-download availability from the Shop lasts **one (1) year** from purchase per Section 2.4).
- For **Subscriptions (10/year and Unlimited)**, for the Subscription Year and any renewals. Download entitlements expire if the subscription lapses; however, **licenses to Reports already downloaded** during an active subscription remain **perpetual for internal use** per Section 3. Re-download access is available only while the subscription is active per Section 2.4.

ZoomCharts may terminate this Agreement (and the applicable license) immediately upon written notice if Licensee breaches Sections 3 or 4. Upon termination for breach, Licensee must cease use and destroy all copies of the Report and derivatives, except that archival backups required by law may be retained securely for recordkeeping and not used.

13. Warranty Disclaimer

THE REPORTS ARE PROVIDED “**AS IS**” WITHOUT WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT. LICENSEE’S USE IS AT ITS SOLE RISK.

14. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY LAW, IN NO EVENT WILL ZOOMCHARTS OR ITS LICENSORS BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, COVER, OR PUNITIVE DAMAGES, OR FOR ANY LOSS OF PROFITS, REVENUE, DATA, OR GOODWILL, ARISING OUT OF OR RELATED TO THIS AGREEMENT OR THE REPORTS, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. ZOOMCHARTS’ AGGREGATE LIABILITY FOR DIRECT DAMAGES WILL NOT EXCEED THE AMOUNTS PAID BY LICENSEE FOR THE SPECIFIC REPORT(S) GIVING RISE TO THE CLAIM IN THE 12 MONTHS PRECEDING THE EVENT GIVING RISE TO LIABILITY.

15. Audit; Compliance

Upon reasonable advance notice, ZoomCharts may request a written statement signed by an officer of Licensee certifying compliance with this Agreement. Where legally permissible, ZoomCharts may also request reasonable information demonstrating that Reports are not being accessed by non-Organization users.

16. Export; Sanctions

Licensee will comply with all applicable export control, trade, and sanctions laws and regulations of the European Union, the United States (including OFAC regulations), the United Nations, and the Republic of Latvia, as well as any other jurisdiction with authority over the Licensee or the use of the Reports. Licensee shall not export, re-export, transfer, or otherwise make available any Report to any embargoed country, restricted territory, or sanctioned person or entity under such laws. Licensee shall immediately inform DVSL of any suspected violation. DVSL may suspend or terminate this Agreement without notice if non-compliance is suspected. DVSL assumes no liability for any breach of export or sanctions laws by the Licensee.

17. Government End Users

Reports are commercial computer software and documentation developed at private expense. Government end users acquire rights only as set forth in this Agreement.

18. Assignment

Licensee may not assign or transfer this Agreement or any rights hereunder without ZoomCharts' prior written consent, and any attempted assignment in violation of the foregoing is void. ZoomCharts may assign this Agreement to an affiliate or in connection with a merger, acquisition, or sale of assets.

19. Governing Law; Venue

This Agreement is governed by the laws of the **Republic of Latvia**, without regard to conflict-of-laws rules, and the courts of **Riga, Latvia** will have exclusive jurisdiction over any dispute arising from or relating to this Agreement, and the parties consent to such jurisdiction and venue.

20. Entire Agreement; Order of Precedence; Changes

This Agreement, together with the purchase terms presented on the Shop (e.g., price, license type, quantity), constitutes the entire agreement between the parties concerning the Reports and supersedes all prior or contemporaneous agreements on the subject. ZoomCharts may update this Agreement prospectively by posting a revised version to the Shop; continued purchases or downloads after the effective date of an update constitute acceptance of the updated terms.

21. Third-Party Software & Visuals (Not Included)

Important Note. When you purchase or download a Report, **no licenses, subscriptions, or rights** to any **Third-Party Software** or **Custom Visuals** are included. This includes, without limitation, **Microsoft Power BI** and any **ZoomCharts custom visuals** referenced by the Report. Licensee is solely responsible for obtaining and maintaining valid licenses, subscriptions, and accounts for any required Third-Party Software and Custom Visuals, and for paying any associated fees. Use of such software/visuals is governed by their separate terms and policies. Report functionality may depend on such software/visuals; lack of the necessary third-party licenses, misconfiguration, or changes by third parties do **not** entitle Licensee to refunds or credits except where required by law.

Exception – Bundled Visual License. Notwithstanding the foregoing, some Reports may include the **Bundled Visual License** described in Section 21A.

21A. Bundled ZoomCharts Drill Down Visuals – Developer License (Desktop-Only)

1. **Scope & Term.** If indicated on the Shop product page for a Report, ZoomCharts provides a **complimentary ZoomCharts Drill Down visuals developer license** valid for **one (1) year** from delivery (**the “Bundled Visual License”**). The Bundled Visual License is limited to **Power BI Desktop** use by the Licensee for development, evaluation, and internal prototyping with the Report.
2. **Desktop-Only; No Service/Production Use.** The Bundled Visual License does **not** cover use in **Power BI Service, Power BI Report Server**, embedded/production deployments, or any external distribution. For those uses, Licensee must obtain appropriate **separate ZoomCharts visual licenses**.
3. **Non-Transferable; No Sublicensing.** The Bundled Visual License is **non-exclusive, non-transferable, and non-sublicensable**, and may be used solely by the Licensee’s Organization.

4. **Governing Terms.** Drill Down Visuals are governed by the **ZoomCharts Drill Down Visuals End User License Agreement** available at <https://zoomcharts.com/downloads/eula-pbi.pdf>. In the event of a conflict between this Agreement and the visuals EULA regarding the Drill Down Visuals, the **visuals EULA controls**.
5. **After Expiry.** Upon expiry of the one-year Bundled Visual License, continued use of Drill Down Visuals (including with the Report) requires a separate, valid license from ZoomCharts. Expiry of the Bundled Visual License **does not affect** the Licensee's perpetual **Report** license under this Agreement.
